The federal government has the power to make a difference. In the coming weeks, permits for construction of Site C will be sough by BC Hydro through federal government departments. It's time for you to put pressure on them to pause and seriously examine and consider the magnitude of damage that this unnecessary project will cause. Consider the key recommendations of the Joint Review Panel: this dam is not needed on the timeline set forth; the costs and energy demand forecasts associated with this dam need more thorough examination; and, more research into alternatives must take place.

The cost of alternative energy has come down considerably in the last two years. According to expert Robert McCullough, Site C i 3x more expensive than the least expensive alternative.

Alternatives are far less risky: they can be built on an as-needed basis, cost less and can provide more jobs in a variety of locations.
